## Marian Olive Storey Campbell

Personal history of Marian Olive Storey Campbell - written by herself, January 1979

Marian |Olive Storey was born 1 June 1889 at North Ogden, Weber County, Utah, the third child of Thomas B Storey and Olive Alberta Chadwick.

Her father, Thomas B Storey Was born 23 Nov 1863 in Tyne Dock, Durham County England. Her grandfather, James Storey Sr. was born 27 Jan 1827, at Monkwearmouth, Durham County England. Her grandmother, Margaret Bell Storey was born 12 Aug 1833 at Simonburn, Northumberland County England.

Her Mother, Olive Alberta Chadwick was born 10 May 1864 at North Ogden, Weber County, Utah. Her grandfather Abraham Chadwick was born 30 Mar, 1921 at Blackely Lancashire County England. Her grandmother Mary Wheeler Chadwick, Was born 8 May 1831 at Gravely Cambridge County England.

Marian was blessed 1 August 1889 in the North Ogden Ward, Weber Stake, Utah by Bishop Thomas Wallace. She was baptized 6 November 1897 in Col Water Creek by Thomas Frances Brown Sr. She was confirmed a member of the Church of Jesus Christ of Latter-day Saints 7 November 1897 by John Rex. She received a Patriarchal Blessing 6 April 1919 in North Ogden by Bishop James Ward.

She started school in North Ogden when she was seven years old. She started in September 1896. On 2 October 1896 her mother died, leaving 4 children (a baby just 4 months old). She attended the North Ogden School until she graduated from the 8th grade May 1904, having only 3 teachers during that time. All impressed her very much and helped to shape her life. One of the teachers became her stepmother. She attended the Weber Academy in Ogden City, Utah, while David O. McKay was the principal. He was chosen to be an apostle of the Church of Jesus Christ of Latter-day Saints during her attendance at that school. The students really missed him when he had to move to Salt Lake City.

When Marian was very small, one of her childhood memories was getting in the Rice Creek, that ran by the house with her clothes on, her mother cured her of this activity by putting her to bed while her clothes dried on the clothesline.

She was taken to Church by her parents when she was very young, so she learned to attend Church very early in life. She has always enjoyed going to church and has always been a regular attender, except when sickness or accident kept her at home. She has held positions in the Primary, Sunday School, and Relief society associations. She has done Temple work for the dead and Genealogy on her ancestors. She has had and seen several faith promoting experiences throughout her life.

Her health has been good all her life, except at intervals. At the age of 12 she had diphtheria, she was one of the first to receive the serum for the decease that controlled it. She had a serious infection after the birth of her last child, Sarabeth, resulting in a long time of illness. After an

operation at age 45, a blood clot formed in her left leg (phlebitis). Part of the clot broke off and lodged in her right lung causing a long confinement. Years later she had another operation (her gall bladder removed). She has had 2 accidents, a broken left leg and crushed knee, 1 July 1975, and later a broken right arm, 27 Sept 1977. During her lifetime she as had to learn to walk three times. The first time when she was a baby, second time after the blood clot, and third after the broken leg and crushed knee. It took a long time, about a year, but she learned to walk again with the help of her children, and her determination to walk again.

After he mother's death, she was a very lonesome little girl (7 years). She had to learn to take care of herself and get to school as her father had to leave very early for work and didn't get back until late at night. Her brother and sister had to do the same. She got home from school earlier than they did, and the house was so cold-there wasn't any automatic heat at that time. Her father got her up early several mornings to show her how to build a fire in the cook-stove so she could be warm. She always was very frightened when she had to strike the match. He had cautioned her to be very careful with the fire, so she wouldn't bet burned, nor the house.

After her father married again (Mary Ann Stimpson) her stepmother, it was different, she was always there and she was so good to the three children. Her father's brother, Samuel and wife Polly took care of the baby sister, she lived with them until she was married.

Marian's teen age was a happy time, she helped with the house work, cooking, picking fruit and helping with the outside work on the farm. She enjoyed the company of her brother Thomas Albert, sister Margaret Louise, half brother Karl Stimpson and half sister Mary Maurine.

Her hobbies were raising flowers, reading and crocheting.

She was married when 20 year old to Warren Delbert Campbell in the Salt Lake Temple on the 20 October 1909. She left North Ogden to live in Liberty, Weber County, Utah. She lived there for 19 years.

During that time she had 4 children, Maurice Ralph, Olive Marian, Halvor Storey, and Sarabeth. She helped her husband by doing the duties in the home for him and children, and helped by her work to pay for the farm they had purchased. Her husband filled four missions while living in the Liberty Ward. A long term, a short term and 2 stake missions. She kept boarders to help pay his expenses of the long term mission. During the short term mission and the two stake missions she and the children milked 30 cows, took care of 700 chickens and other stock on the farm, did the housework and kept the children in school. It was a lot of hard work. Her brother Albert came and helped them out.

In November 1928 they sold the farm and moved to Clearfield, Davis County, Utah on a small farm (20 acres). After a few years of farming they sold 7 acres of the farm for a cemetery. The rest of the farm was divided into lots and houses were built on them and sold.

She and her husband went on a w moth trip (January - February, 1947) around South American. He died 24 January 1954.

During her lifetime she saw and experienced several wars, her father was eligible for the war of 1898. In the First World War it was her husband and brother, Second World War, her sons-sons-inlaw. Her son Halvor was drafted and was in the military service for 3 years leaving a wife and 2 small children. |Korea and Vietnam Wars in was her grandsons, several of these were in the military camps for training.

In her life span, she has seen many changes. Home-coal oil lamps to electricity and all its advantages. Transportation, walking, horse and buggy to automobile, airplanes to man walking on the moon. Machinery - horse drawn plows to automatic machines. Houses - log houses to brick and frame. Roads - dirt roads to cement and oil surfaces. Medicine-serums discovered to control childhood deceases, diphtheria, small pos, typhoid fever and polio.

She was greatly influenced all her life by the example that her parents and grandparents set. They were so kind and devoted to the Gospel.

She has lived in North Ogden, Liberty, Weber County and Clearfield, Davis County. Since her release from the hospital and nursing home, after her broken leg and crushed knee she came (27 December 1975 to her daughter's home in California. She sold her home in Clearfield, Utah.

The following was added by a family member:

Mother fell at her Clearfield home on July 1, 1975 and was in McKay hospital for 3 weeks then two months at Crestwood Care Center. Mother shattered her left knee. Sally and Pete took mother for 4 years to California to care for her and to live with them, where she learned to walk again. Mother's home was sold in the Fall of 1975. In September, 1979 Mother returned to Utah and rented an apartment at Versailles 3290 Van Buren Ave. Ogden, Utah. She required family and home care at the apartment from September 1979 to December 1985. Mother had several strokes and entered the Mount Ogden Nursing Home, 375 E. 5350 South from December 3 to March 1, 1986. On March 1, 1986 mother was again taken by Sally and Pete to Auburn, California to live with them until October 1, 1987. At that time she returned to Ogden and entered Washington Terrace Nursing Center and resided there for one year and 1 moth. She died November 7, 1988 at the age of 99 and five months. Funeral were November 12, 1988 at the Clearfield Mortuary, Clearfield, Utah.
